Business Judgment Rule Definition

When you place a non-spouse on your property as a joint tenant, you make an immediate gift of one-half the value of the property. For example, when a mother retitles her \$80,000 home in joint tenancy with her son, she has just given her son a \$40,000 gift. The first \$14,000 doesn't count but the law requires that she file a gift tax return.
