- Members may receive either the Welcome to Medicare Visit or the Annual Wellness Visit, along with the Annual Routine Physical Exam, on the same day from the samePCP, as long as all components of both services are provided and fully documented in the medical record. Please don't submit either of these two visits with a -25 modifier.
